

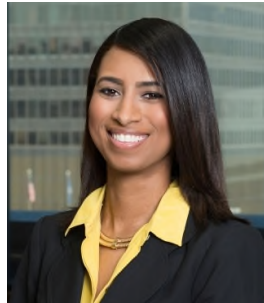

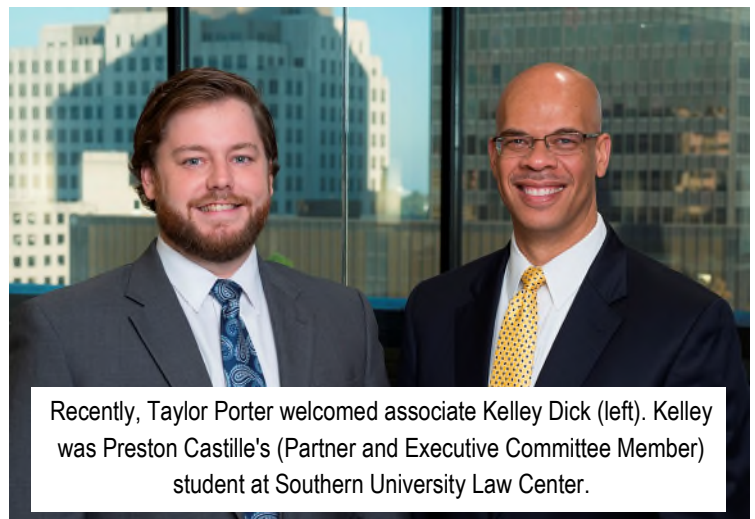

# Our Diversity Outreach and Community Impact

Whether serving on the boards of directors of nonprofit organizations or making contributions to worthwhile causes, Taylor Porter's attorneys and staff are actively involved in the community. Some examples of these organizations include:

**100 Black Men of Metro Baton Rouge** - Partner and executive committee member Preston Castille is an active member of the 100 Black Men of Metro Baton Rouge. Recently-retired partner and diversity committee member Deborah Lamb, received the "Portrait of Caring" award from Cox Communications and 100 Black Men of Metro Baton Rouge for her efforts to promote diversity and unity in the Baton Rouge community. Taylor Porter also sponsors or donates to events benefiting this organization devoted to helping African-American males assume roles of community leadership, responsibility and guidance.

**Volunteers in Public Schools** - Deborah Lamb served on the VIPS board of directors for many years and currently serves on its advisory panel, while associate, Ne'Shira Millender, currently serves as a board member. Taylor Porter received a Golden Apple award from VIPS for its work at Kenilworth Middle School, and was recognized by the East Baton Rouge Parish School Board for its partnership with the Dufrocq School through VIPS.

**Cristo Rey Baton Rouge High School** - Taylor Porter has committed to serving as a corporate sponsor to Cristo Rey Baton Rouge High School, a Catholic high school opening in August 2016. The school combines college prep education with a corporate work study program through which several Cristo Rey students will work at Taylor Porter. In 2016, Taylor Porter donated 265 pounds of food, \$1,530, and attorneys and staff volunteered on site sorting food donations and assembling sorted items into food boxes, totaling 6,243 pounds of food for 1,100 families.

**Baton Rouge Blues Foundation** - Partner Anne Crochet helped chair the 2015 Annual Blue Carpet Blues Gala for the Baton Rouge Blues Foundation, a non-profit that promotes, preserves and celebrates Baton Rouge blues culture. Among other projects, the Foundation sponsors a Blues Education program and Blues Music History Project, to help artists in need. Taylor Porter was a sponsor of the 2015 gala.

**Baton Rouge Symphony Orchestra** - Partners Blue Loupe and Deborah Lamb serve on the board of the BRSO, and Taylor Porter sponsors several BRSO performances throughout the year.
